Declaration of Conformity PFAS

Per- and Polyfluoroalkyl Substances (PFAS) are synthetic organofluorine chemical compounds that have multiple fluorine atoms attached to an alkyl chain & widely used in industry & consumer products. These chemicals are persistent and bio-accumulative in the environment and generate adverse effects on human health.

PFOS, PFOA, PFHxS, and PFCAs are included in the **International Stockholm Convention** to eliminate their usage. Similar restrictions are placed in European Union, under the EU's **Persistent Organic Pollutants (POPs) Regulation**. Recently ECHA has proposed restriction of around 10000 PFAS substances including fluoropolymers, which are widely used in all industries under **REACH regulation**. US EPA has finalized PFAS reporting requirements under **TSCA Section 8(a)(7)** and it is effective from Nov 13, 2023. As per **TSCA Section 8(a)(7)**, EPA is requiring persons that manufacture (including import) or have manufactured these chemical substances in any year since January 1, 2011, to submit information to EPA regarding PFAS uses, production volumes, by-products, disposal, exposures, and existing information on environmental or health effects. This declaration also notices with respect to certain per- and polyfluoroalkyl substances (PFAS), published in the Canada Gazette, Part I on July 27, 2024, pursuant to paragraph 71(1)(b) of the Canadian Environmental Protection Act, 1999 (CEPA)."

This declaration letter certifies the absence of PFAS substances in the below-listed parts manufactured by ERP Power, LLC.
